- b. Note on page 6 of the Summary, the trend in the percentage of commercial vehicles (line) on Station Road, The Folly and Stowmarket Road have increased at a greater rate than that of the other roads in the study. It should also be noted that all roads in the study have a percentage of commercial vehicles in excess of what would be expected for the national UK average for the road type (Rural Minor Road).
